HOLD HARMLESS AGREEMENT
Schedule of Insurance

Notwithstanding the indemnification and defense obligations of the Contractor, the “Contractor” shall provide at its own cost and expense proof of the following insurance* to the City of Northfield:

Commercial General Liability	\$1,000,000
Automobile Liability	\$1,000,000
Workers Compensation	Statutory

* The City of Northfield is to be named as "Additional Insured"

Failure by the Contractor to supply such written evidence of required insurance and to maintain same for the duration of this contract shall result in default under this contract.

The insurance companies for the above coverages must be licensed by the State of New Jersey and acceptable to the City of Northfield. The “Contractor” shall take no action to cancel or materially change any of the insurance required under this Contract without the City of Northfield’s prior approval. The maintenance of insurance under this section shall not relieve the “Contractor” of any liability greater than the limits or scope of the applicable insurance coverage.
