RE: Shared Services Feasibility Study for Countywide Fire and EMS Centralized Dispatch

Dear Mayor:

We have received interest and written support from the Atlantic County Firefighters Association, the Atlantic County Fire Chiefs' Association and the EMS Chiefs of Atlantic County for a feasibility study to determine the viability of countywide Fire and EMS centralized dispatch.

If we have support from our towns for this study, the county is prepared to apply for a shared services LEAP Challenge grant to provide funding. The grant application is due on March 15, 2023. Prior to that date, we would need a copy of your adopted resolution supporting the feasibility study or a letter confirming your support and plans to adopt a resolution. Please return those documents to Linda Gilmore at gilmore_linda@aclink.org. For your convenience, I have enclosed a sample resolution.

Centralized dispatch has been discussed for many years. Before the county proceeds with any plans, a feasibility study would be needed. The shared services grant program provides an ideal opportunity to take a fresh look at the benefits, costs and challenges associated with centralized dispatch.
