## **Basketball Courts Birchgrove**



- Partnering with the City in supporting the idea of placing the basketball courts in the back of Birch Grove Park, tucked away from the main thruway of traffic
- Utilize the space as well as the snack bar and bathrooms

### HERE'S WHAT INDEPENDENT REVIEWS OFTEN FIND WHEN COMPARING NATURAL GRASS AND ARTIFICIAL TURF FIELDS:

"Despite the higher up-front and future replacement costs, an artificial turf MCPS Stadium field provides a substantially lower net cost per hour of use than any of the natural grass options because of the substantially increased hours of use and additional revenue generated from that increased use."

- MONTGOMERY COUNTY WORK GROUP -

Yes Turf is a high upfront cost and has future replacement costs, but it's lower cost per hour of use and increase hours of use would be generating revenue for years to come. Year after year the Northfield playing fields are deemed unplayable with a major draining issue and increased costs of replacing grass.

\*\*By missing the opportunity to host playoff and championship games this year FAN took a hit of at least \$10,000\*\*

A consideration of turf can help alleviate these issues as well as provide our community with a state of the art athletic facility where families will travel for youth sports and in turn enhance our economy!

\*\*FieldTurf will be happy to provide a more in depth presentation should city council consider this as a realistic option for Northfield\*\*

# Repairs and Upgrades to Football Tower, Snack Bar, and Bathrooms

 These events will generate revenue through "field rental", snackbar, and overall enhancement of the community as people will visit our town and is also a "Gateway to the Shore"

#### **Brick fundraiser**

 Fundraiser to sell engraved bricks to community members, past and present, to be used as a memorabile in addition to laying a beautiful landscape to surround our fields

### What we hope our city can commit to:

- Submit paperwork for grants made available through Covid relief programs, specific to the health and wellbeing of our children
- Fund the projects deemed approved through various grant opportunities
- Allocate funds each year for the betterment of all youth sports programs and facilities
- Work with FAN on having full access to bball courts to allow for organized clinics and leagues to be run.
- Open snack bar and bathrooms in back of Birch Grove Park
