The plan titled Bicycle Network Project as prepared by Schaeffer Nassar Scheidegg Consultin Engineers, LLC and signed by Daniel Kwapinski, PP, PE, CME dated 10/11/2016, proposes to add 17,740 feet of designated bike lanes and 44,260 feet of shared bike lanes through out the City of Northfield, fot a total of 11.742 miles of additional bike routes.

The City of Northfield has adopted a copmlete streets policy and is proposing improvements to comply with this policy. The design focuses mainly on two important areas of Northfield, the Regional Bike Path and Birch Grove Park. These two areas are located at opposite areas of the city, the Regional Bike Path is in the Southern section of the city and Birch Grove Park is in the northern section.

The plan was designed using the NJDOT, Atlantic County and Northfield city board approved plan "Northfield Bicycle and Pedistrian Plan" dated October 2015 as the primary guide.

The City proposes to designate bike lanes on Burton Ave from Mill Road to Jackson Ave

and on the roadway leading to the entrance of Birch Grove Park. Most of this existing roadway is at least 30' wide and can accomplish 5' bike lanes in each direction by adding striping only. At the intersection of Burton Ave and Mill Road,

there is a city owned property, minor road widening will needed to allow for the proposed designated bike lanes.

The plan proposes to add shared bike lanes on the following roadways within the city limits: Oak Ave from Mill Road (County Route 662) to Burrough's Ave Ridgewood Ave from Oak Ave to Shore Road (County Route 585) Cedar Bridge Road from Oak Ave to The Regional Bikepath Yorkshire Ave from the Regional Bikepath to Bay Drive Bay Drive from Yorkshire Ave to Mill Road (County Route 662) Oak View Drive from Shore Road (County Route 585) to the Regional Bike Path Northfield Ave from Shore Road (County Route 585) to the Regional Bike Path Jackson Ave from the Regional Bikepath to Burton Ave Burton Ave from Jackson to Evergreen Ave Evergreen Ave from Burton Ave to Lake Ave Lake Ave from Evergreen Ave to Harvey Drive Harvey Drive from Lake Ave to Dolphin Ave (County Route 644)

The project also proposes the addition of sidewalk along Jackson Avenue to complete the sidewalks in critical areas. Minor access and striping improvements are proposed on the roadways that intersect with the Regional Bikepath.

Within the city limits of Northfield, there is 2 miles of pedestrian / bike pathway that is part of the Regional Bikepath. The Regional Bike Path is approximately 9 miles in length spanning Pleasantville to Ocean City. The portion that runs through Northfield is located in the southern quarter of the city. This project proposes to create 62,000 feet of new bikeways that will allow all the residents of Northfield to safely reach the Regional Bikepath, as well as, Birch Grove Park, the Northfield Community school and many other destinations through out the City.

The new lanes would also allow residents of neighboring communities that use the Regional Bike Path to easily and safely gain access to Birch Grove Park, which offers additional recreation for the entire family. The City often holds community events at Birch Grove Park. We anticipate that with safer alternative access to Birch Grove Park, those events will have less motor vehicle traffic and more participation.

A portion of the new shared bike lane will run along Cedar Bridge Road which runs on the westerly side of the Northfield Community School property. The school has an enrollment of close to 1,100 children in grades Kindergarten through 8th, and does not offer bus transportation to the students of the school. Currently, alternate transportation and parent drop-off is the primary method of transportation to the school

By creating new bike lanes near the school it would provide the students with a safe and healthy way to commute to school that won't rely on motor vechicles.
