

CITY OF NORTHFIELD REGULAR MEETING MINUTES DECEMBER 16, 2025

At 6:54pm this meeting was called to order by Municipal Clerk Mary Canesi. This meeting was properly advertised in the Press of Atlantic City on January 11, 2025, and in accordance with Public Law 75, Chapter 231.

FLAG SALUTE

Mayor Chau led the flag salute followed by a moment of silence.

ROLL CALL

Present: Councilwoman Carfagno; Council Dewees; Councilwoman Kern; Councilman Notaro; Councilman Polistina; Councilman Smith; Council President Bucci.

Mayor Chau, Solicitor Facenda, Engineer Mauro, and Chief VonColln were also present.

READING AND APPROVAL OF THE MINUTES

On a motion by Councilman Polistina with a second by Councilman Smith, all members present were in favor of approving the minutes of November 25, 2025, without formal reading.

MAYOR'S REPORT

Mayor Chau announced an attempted robbery at TD Bank, there were no injuries and the investigation was ongoing. We had a sink hole last week, 10-15 feet deep, there was no damage to any equipment or apparatus. He thanked members of Council who attended the Holiday Tree Lighting, he thanked Council President Bucci for standing in for him. He attended the reorganization meeting for the county Solid Waste Advisory Council (SWAC); they were planning to expand the usage of the landfill by opening up another area parallel to the parkway that should add another 10-15 years. Recycling revenue was down, but we were saving space in the landfill by recycling. The County was also addressing the odor complaints related to the landfill.

Mayor Chau read the Police Department report for November. He noted the high police overtime for this period was related to the sinkhole Mayor Chau had mentioned earlier. There were two Resolutions on the agenda tonight for the Police Department and the MOA, and he believed Nicole would be coming in to answer any questions. He wanted to backtrack and respond to several questions and concerns with regard to the MOA. Mayor Chau spoke to every candidate, which was the sergeants and asked them if they were aware of City Council changing the qualifications, all said yes. The MOA has been signed. This doesn't affect the captain and lieutenant positions, just chief. He reminded Council that qualifications for employment were not negotiable, or grievable.

Mayor Chau continued, the County was moving forward with revaluations, when Northfield would be asked, he did not know. He suggested that the Council put some monies aside now, when budget time comes; he believed it will cost upwards of \$500k plus the cost of tax maps.

ENGINEER'S REPORT

Engineer Mauro reported on the slip line project; the manhole at Shore Road was repaired, but now there was a gas line preventing Mathis from replacing a portion of the pipe. Regarding slip line we have a question in to the vendor regarding the potential of slip lining a portion, and then having Mathis do the balance. With regard to MS4 compliance, she listed what had been updated. All that remained was the map. DeBlasio and Associates sent out an end of year report, she reviewed highlights of that list. It had been a pleasure working with all, wishes all a Merry Christmas and Happy New Year.

Mayor Chau announced the Holiday Light contest, he thanked all of the businesses who donated, and thanked Deputy Clerk Campbell for coordinating the project.

Councilwoman Kern asked about the Community Development Block Grant.

Engineer Mauro replied she reached out to the County with no response. The project was submitted to Congressman VanDrew was not awarded.

PUBLIC SESSION

Council President Bucci opened this meeting for any member of the public to speak on any topic.

Seeing no one wishing to speak, Council President Bucci closed the public session.

RESOLUTIONS / CONSENT AGENDA

The minutes would be kept and made available when permitted and required by law. The timeframe for the release of those minutes is unknown. Council will remain in Council Chambers and return to the public session when the Executive Session is complete for a short statement. Official action was anticipated to be made regarding this executive session in the form of Resolution 245-2025.
