

**CITY OF NORTHFIELD, NJ
ORDINANCE NO. 19-2025**

**AMENDING CHAPTER 250, ARTICLE II OF THE CITY CODE,
BIRCH GROVE PARK, VETERANS PARK, FIRST STREET
PLAYGROUND, AND NORTHFIELD BIKE PATH REGULATIONS**

BE IT RESOLVED, by the Common Council of the City of Northfield, County of Atlantic, and State of New Jersey that Chapter 268 of the Code of the City of Northfield is hereby amended as follows (added text underlined; deleted text ~~stricken~~):

§ 250 ARTICLE II - Birch Grove Park, Veterans Park, First Street Playground, and Northfield Bike Path Regulations

§ 250-2. Prohibited activities

A – G NO CHANGE

H. Low-Speed Electric Bicycles², Low Speed Electric Scooters², Motorized Bicycles², Motorized Scooters², Motorized Skateboards², and Hoverboards and other Electric Personal Assistive Mobility Devices³.

- (1) In Birch Grove Park, Veterans Park, and the First Street Playground, operation of any of the above devices shall be limited to parking areas and roadways only.
- (2) On the Northfield Bike Path, Low-Speed Electric Bicycles² (Includes Classes I and II) are permitted.
 - a. On the Northfield Bike Path operation of any of the other devices listed above is prohibited

BE IT FURTHER RESOLVED:

- 1) This ordinance shall take effect upon final passage and publication in the manner prescribed by law.
- 2) Repealer. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.
- 3) Severability. If any Section or part of this Ordinance is deemed to be invalid or illegal in any Court of competent jurisdiction then said part is severable from the Ordinance as a whole and the remaining sections or parts of this Ordinance shall remain in full force and effect.
