Mr. Brophy said the sign was stationary as of two days ago. Dr. Levitt commented that it has been scrolling all hours of the night and is multicolored. Mayor Chau asked if Dr. Levitt had alerted the Zoning Official and he said yes. Mayor Chau mentioned that he has also spoken with the Zoning Official about the number of flags on Tilton Road in front of the Cresson Hill Apartments roadway.
