SUPPORTING THE CLICK IT OR TICKET MOBILIZATION OF MAY 18-31, 2015

WHEREAS, there were 556 motor vehicle fatalities in New Jersey in 2014; and

WHEREAS a large percentage of the motor vehicle occupants killed in traffic crashes were not wearing a seat belt; and

WHEREAS, use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle crash; and

WHEREAS, the National Highway Traffic Safety Administration estimates that 135,000 lives were saved by safety belt usage nationally between 1975-2000; and

WHEREAS, the State of New Jersey will participate in the nationwide Click It or Ticket seat belt mobilization from May 18 - 31, 2015 in an effort to raise awareness and increase seat belt usage through a combination of high visibility enforcement and public education; and

WHEREAS, the Division of Highway Traffic Safety has set a goal of increasing the seat belt usage rate in the state from the current level of 88 percent to 90 percent; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways;

THEREFORE, BE IT RESOLVED that Northfield City Council declares its support for the *Click It or Ticket* seatbelt mobilization, both locally and nationally, from May 18 - 31, 2015 and pledges to increase awareness of the mobilization and the benefits of seat belt use.
