# WORK CHANGE ORDER NO. 1 CRESSON AVENUE DRAINAGE IMPROVEMENTS

WHEREAS, pursuant to Resolution of Council No. 57-2017, the City of Northfield did award a contract for the project known as "Cresson Avenue Drainage Improvements" and did enter into a contract with Landberg Construction, LLC. ("Contractor"), for the amount of \$304,423.91; and

WHEREAS, during performance of the project, certain previously existing but unknown utility conflicts were discovered, resulting in the need to make design changes in the field. Additional structures were installed and different types of pipe were needed. Said conditions required and necessitated additional unanticipated work, material and labor at a total cost of \$15,719.64, incorporated herein as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that the Contract for "Cresson Avenue Drainage Improvements" be amended from \$304,423.91 to \$320,143.55 for a net increase of \$15,719.64.
