WHEREAS, the City of Northfield did award a contract for the purchase and installation of a telephone system and did enter into a contract with Tricomm Services Corporation for the amount of \$29,562.84 and;

WHEREAS, during performance of the project, additional equipment was needed and some additional work was required to properly complete the project and connect the Public Works building telephones to the municipal system.

NOW, THEREFORE, BE IT RESOLVED that the contract for the purchase and installation of a telephone system with Tricomm Services Corporation be amended from \$29,562.84 to \$33,713.72 for a net increase of \$4,150.88.

## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTHFIELD, COUNTY OF ATLANTIC, NEW JERSEY AUTHORIZING A GOVERNMENTAL ENERGY AGGREGATION PROGRAM AND APPOINTING COMMERCIAL UTILITY CONSULTANTS, INC. AS ENERGY AGENT TO ASSIST THE CITY IN THE IMPLEMENTATION OF THE CITY'S ENERGY AGGREGATION PROGRAM AND MAKING OTHER DETERMINATIONS IN CONNECTION THEREWITH

WHEREAS, the State of New Jersey has been engaged in a process to establish a competitive market place through deregulation and restructuring the electric and natural gas utility markets; and

WHEREAS, the establishment of a governmental energy aggregation program ("GEA Program") to purchase electric generation service and natural gas pursuant to the Government Energy Act of 2003, *N.J.S.A.* 48:3-93.1 *et seq.* ("Act") and the New Jersey Board of Public Utilities' implementing rules at *N.J.A.C.* 14:4-6.1 *et seq.* ("Rules") is intended increase competition for the provision of electric power and natural gas to residential and non-residential electricity and gas ratepayers, thereby possibly increasing the likelihood of lower electric rates and natural gas rates for these users without causing an interruption in service; and

WHEREAS, under a GEA Program the residential and non-residential electricity and gas ratepayers may have the opportunity to receive a direct reduction in their electric bills and gas bills through the bulk purchase of energy from a third-party energy supplier; and

WHEREAS, the potential for a realization of energy costs savings is deemed to be in the interests of the health, safety and welfare of the residents of the City of Northfield; and

WHEREAS, pursuant to Ordinance 13-2013 adopted by the City of Northfield on October 22, 2013, the City of Northfield publicly declared its intent to commence a GEA Program within the City of Northfield and to become an aggregator of electric power and natural gas on behalf of its residential and nonresidential electricity and gas ratepayers pursuant to the Act and the Rules; and

WHEREAS, pursuant to the "Local Unit Electronic Technology Pilot Program and Study Act" (P.L. 2001, c.30) ("E-Procurement Act"), administered by the New Jersey Department of Community Affairs ("DCA"), the State of New Jersey has established a pilot program for the electronic purchase of certain commodities and services; and WHEREAS, the E-Procurement Act allows municipalities in the State of New Jersey to purchase commodities and services, including energy supply, through online bidding and reverse auction programs approved by the DCA without the requirement of the traditional public advertisement and bidding requirements contained in the New Jersey Local Public Contracts Law (N.J.S.A. 40A:11-1 *et seq.*); and

WHEREAS, pursuant to Ordinance 13-2013, the City of Northfield appointed Commercial Utility Consultants, Inc. ("CUC") to assist the City of Northfield with the selection of a third-party energy supplier in connection with its energy aggregation program through the use of CUC's Reverse Energy Auction Platform pursuant to the E-Procurement Act; and

WHEREAS, the City of Northfield believes that it will benefit from the assistance of CUC, which has been approved by the New Jersey Board of Public Utilities ("BPU") to serve as an Energy Agent as defined in the Rules, with the GEA Program; and

WHEREAS, CUC has agreed to serve as the Energy Agent for the City of Northfield's GEA Program at no cost whatsoever to the City of Northfield; and

WHEREAS, the City of Northfield hereby finds that it is in the best interests of residential and non-residential electricity and gas ratepayers of the City of Northfield to appoint CUC to serve as Energy Agent in connection with the GEA Program pursuant to the E-Procurement Act.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Northfield in the County of Atlantic, New Jersey, duly assembled in public session, as follows:

1. The City of Northfield hereby appoints CUC to serve as Energy Agent to assist the City of Northfield with the administration of its energy aggregation program, provided CUC's service as Energy Agent is completely and unconditionally at no cost to the City of Northfield and provided said service is in accordance with a written agreement to be executed between the City of Northfield and CUC.

2. The Mayor, Chief Financial Officer, Treasurer or other municipal officer is hereby authorized and directed to execute, on behalf of the City, any documents necessary, in a form acceptable to the City Council for the City of Northfield and its Solicitor, to carry out the purpose of this Resolution.

3. All resolutions, or parts thereof, inconsistent herewith are hereby repealed and rescinded to the extent of any such inconsistency.

4. This resolution shall take effect immediately upon adoption.

**3) CONTRACTING UNIT** - The Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

4) EFFECTIVE DATE - This resolution shall take effect immediately upon passage.
