If use of Parking Areas <u>is proposed</u>, how many parking spots will be used for seats / tables: ______Grass-covered or landscaped areas shall not be used for temporary outdoor seating. Temporary outdoor seating shall not be located within 30 feet of any property boundary adjacent to a County roadway. If approved, temporary outdoor dining shall only be permitted between the hours of 6am and 10pm.

The following shall be submitted along with this application: a site plan and site drawing depicting the proposed layout and location of tables/seating outside of said bar/restaurant, which shall also include but not be limited to, a depiction of all aisles, routes of ingress and egress, clearances/distances between tables and between the seating area and the curb line, the location of all food preparation and service areas, an illustration, rendering and/or photograph of all proposed furniture, umbrellas, tents, and trash receptacles. All proposed tables, chairs, furniture, umbrellas, tents and trash receptables, etc. on site must be of similar nature and appearance. Applicants shall also submit a brief written narrative describing the proposed method of serving food and beverages in the newly proposed areas. Applicants must submit a Litter Control Plan, which shall include a description of the number and location of trash receptacles proposed to service the outdoor dining area, and the frequency with which the outdoor dining area will be policed for litter in order to control the accumulation of trash/recycling. Applicant must sign the attached 'hold harmless agreement'; must provide a certificate of insurance naming the City of Northfield as an additional insured under a policy of insurance to not be less than \$1,000.000.00, and must provide a copy of the 'additional insured endorsement'.
