Additionally, while we have the attention of our enthused audience, we will educate the children in our community on drug and alcohol awareness.

The Northfield Police Department Bike Rodeo will provide an opportunity for bicyclists to practice and develop skills that will help them to become a better bicyclist. The goal of our bicycle rodeo is to provide an opportunity for the participants to learn, practice, and demonstrate their bicycle handling skills in a fun, noncompetitive atmosphere.

Our Northfield Police officers are role models. The best teacher is one who teaches by example. The Northfield Police Department will have certified Police Bike Instructors working in small groups emphasizing education, awareness and safety.
