At 7:36pm, this meeting was called to order by Mary Canesi, Municipal Clerk. It was advertised in the Press of Atlantic City on January 7, 2013, in accordance with Public Law 1975, Chapter 231.

The flag salute was led by Mayor Vincent Mazzeo. Following the flag salute a moment of silence was observed.

## **COMMITTEE REPORTS**

Councilman Perri said there would be a Seniors Committee meeting Thursday at 6pm at City Hall, and a Seniors Luncheon at the Country Club on February 7<sup>th</sup>. The luncheon can accommodate 50 attendees and County Intergenerational Services will be in attendance to provide an overview of available services. Perri said there will be a new slate of officers that he would like approved by the governing body.

Councilman O'Neill said the City is looking at VOIP for our phone system, and preliminary numbers from Kathi Smith in Finance look to bring considerable savings. He also mentioned looking for a new IT vendor who is local. Our current vendor is great but we pay travel time.

Councilman Travagline said he is still learning the bill process, and that Councilman Polistina and the CFO have been helpful. There will be a budget meeting with all three next month.

Councilman Polistina read the EMS report; he said there are disputed times that are being investigated and that he will report with more information at the next meeting. He read the Fire Department for 2012, and sail preliminary budget meetings will begin soon.

Councilman Dewees stated that there was an error on the trash route map that affected recycling collection; it has been corrected.

Councilman Carew had no committee report this evening.

## COUNCIL PRESIDENT'S REPORT

Council President Brown had no report this evening.

#### MAYOR'S REPORT

Mayor Mazzeo stated that Shannah Smith had been reappointed as Library Board President, and said she is doing a great job. The addition is coming along and he encourages anyone interested to visit. Mazzeo noted the Planning Board reappointments as well. He provided an update on the Cedar Bridge Road home that was damaged in the storm; we are working with the bank and our last communication from them was that they were going to seek a demolition contractor. Mazzeo spoke with the Police Department in light of the incidents in Connecticut. He said the police and the school will be working to enhance their presence at the school, including unannounced visits. He read the Police Department report. Mazzeo said Chief James has recommended that the City change the towing ordinance to limit to four the maximum number of towing providers who can be licensed; Mazzeo agrees with this recommendation.

Council President Brown requested that the solicitor draft the amendment to the towing ordinance for Council's consideration. Councilman Polistina asked what would happen to our other towing vendors; Mazzeo replied that we only have four, but that is all that we want.

Solicitor Facenda stated that a resident named Mr. Yarger of 137 East Revere Avenue had filed an insurance claim with the City when a tree from the Bird Sanctuary fell and damaged his porch during Hurricane Irene. The closed session will be convened to discuss that claim and a settlement offer that Mr. Yarger has proposed. He does not feel the City's strategy will be disclosed but if there is a decision, it will be disclosed and voted on in public.

At 7:59pm, Council left the dais and entered the City Clerk's Office; Solicitor Facenda, Mayor Mazzeo and Deputy Clerk Mimi Marlor were also in attendance.

At 8:21pm, the closed session was adjourned and the regular meeting of Council resumed. Facenda announced a summary for the record as follows: during the closed session Council discussed the claim. Yarger has made a settlement offer to Council and Council considered it. His claim was rejected. Council has proposed an alternative solution that they would like to convey to Mr. Yarger. Facenda requested that Council consider that the City pay the property owner of 137 East Revere Avenue the sum of \$500 in full and final settlement of all claims and any potential litigation, and that there is no admission of guilt on the part of the City. These terms would be part of a release that make the matter final.
