At 7:56pm, this meeting was called to order by Municipal Clerk, Mary Canesi. This meeting was properly advertised in the Press of Atlantic City on January 9, 2021, in accordance with Public Law 1975, Chapter 231.

Due to social distancing requirements related to Covid-19, there are limited seats for in-person attendance by members of the public. Face coverings and social distancing will be required for in-person attendance. Comments shall contain the name and address of the author, will be read aloud and addressed during the remote public meeting, and must be received by 2:00pm on August 10, 2021.

Municipal Clerk Canesi read the following statement:

"As you may know, in late May, Governor Murphy issued Executive Order No. 242, related to Covid-19 and which eased restrictions on face coverings in indoor public spaces, under certain conditions. The order permits employers to impose stricter requirements regarding face coverings in indoor settings, which, in the best interests of our employees and visitors, the City of Northfield opted to do in May, and continues to do. Based on CDC guidelines, the City of Northfield continues to require face coverings and social distancing in our indoor public spaces, and visitors are made aware of this decision with signs at the entrances to the building.

Due to the continued social distancing requirements, there are limited seats for inperson attendance by members of the public this evening. This meeting is also being presented simultaneously as a remote public meeting, live-streamed, using Zoom conferencing service, and in accordance with the Governor's Executive Orders, the Open Public Meetings Act.

Zoom meeting participants can dial in by telephone and listen to the proceedings, or they can access the meeting using a web-browser, and be able to view and listen. Instructions on how members of the public could reserve one of the limited seats, as well as how they can access Zoom have been made available on the municipal

website and were published in the Press of Atlantic City. At this time, one by one, any telephone users will be asked to identify themselves and will be unmuted to permit commentary. For web-browser participants, comments or questions may be submitted via the chat function and will not be acknowledged outside of the designated public-comment portion of the meeting; chat-users must also provide his/her name and address for the record in order to be heard.

Any written comments submitted in advance will be read aloud and addressed during the public comment portion of the meeting."

# FLAG SALUTE

The flag salute was led by Mayor Chau followed by a moment of silence.

### **ROLL CALL**

**Present (in person)**: Councilman Dewees; Councilwoman Madden; Councilman Notaro; Councilman Perri; Councilman Smith; Councilman Utts; Council President Polistina; Mayor Chau.

Solicitor Facenda, Engineer Nassar and Chief Newman were also in attendance.

### **READING AND APPROVAL OF THE MINUTES**

On motion of Councilman Perri with a second of Councilman Notaro, all members present were in favor of approving the minutes of July 13, 2021 without formal reading. They were posted, distributed to Council, and on file in the Municipal Clerk's Office.

### **MAYOR'S REPORT**

Mayor Chau announced he would pull the August winner for recycle contest tomorrow and announce the winner. He created the program and pays for the container himself. Northfield was in the top recyclers in Atlantic County. He thanked all. He was proud to announce the new bus shelter at Oakcrest and Shore was moving

forward, he hoped it to be complete by year's end. He announced the Body Worn Camera grant, \$48,912.00, to purchase body cams and necessary equipment. Kudos to Chief Newman and his department for pursuing the grant. As Councilman Smith pointed out, there would be a joint court meeting tomorrow. The County should be able to present firmer financial numbers, committees would be identified, and we could move forward. We heard comments regarding businesses vacating along Tilton Road, we were all aware of the effects of Covid 19 and the problems associated with it. In past two months we've had 12 new businesses open or express interest. Mr. Howell asked what Council did to promote businesses. We had certain limitations. It's a big pie, we have Council members who serve as liaisons to the schools. This brings in businesses. Councilman Utts, Councilman Perri and Mayor Chau have served on the Planning Board, we were looking for businesses but we were looking for quality businesses, this addresses taxes and community development. He offered kudos to Council. There was a lot done behind the scenes. The owner of McDonald's in Northfield has donated free ice cream cones, the program developed along with Chief Newman, to support and reward children who practice safe habits with bicycling. Northfield Police Department would be hosting a bike rodeo. He thanked the owner of McDonald's; this was the fourth year they have done that. Regarding comments and suggestions that were made to Mayor Chau, he holds no malice, this is America and we were all entitled to our opinions. He thanked all for their comments and concerns, whether they agree or disagree.

#### **CITY ENGINEER'S REPORT**

Engineer Nassar reviewed the Engineer's Report as previously distributed to the Council. Final payment was on the agenda for the City Hall project; the maintenance bond was on file. There was a change order due to the price of fuel, it was close to a \$5,000.00 increase, sometimes it works in your favor, sometimes not. Also, at the library when the bumper stops were removed, the majority were broken and had to be replaced, and lastly the asphalt curbing at the rear of the municipal building had to be raised to address a flooding concern that was affecting the resident who lives behind the municipal building. That resulted in an increase of \$16,203.15. The 2020 Local Road punch list items were being addressed. There was also an issue at Tilton and Roosevelt due to settling. He had asked the contractor to get us a price, we have to get it done, it's been a long time. The cost will be around \$10,000.00, it's a big area and castings for manhole have to be raised. The project will be done overnight.

Clerk Canesi asked Engineer Nassar if it would be on the next agenda?

Engineer Nassar would like to have approved tonight. He had verbal approval on availability of funds from CFO Stollenwerk.

Council President Polistina asked if Solicitor Facenda has prepared a resolution to be added to agenda?

Councilman Dewees did not want to wait until the 31<sup>st</sup> to vote.

Engineer Nassar noted the cost would be \$10,743.86 and the vendor was South State.

Engineer Nassar reported that Fuae Avenue was substantially completed, there were punch list items and some documents that needed to be provided. He was waiting for a start date from the contractor. Regarding Municipal Aid 2021, the package was sent to NJ Department of Transportation, he was waiting to hear from them as well.

Engineer Nassar and Councilman Perri discussed the slip lining project, they had the preconstruction meeting, Public Works was there, along with members of the Northfield Police Department. Public Works would need to be present for the Slip Lining Project, an inspector from his office was not qualified to do that. He discussed with Superintendent Vitale, who would come up with a recommendation. Some work would be done overnight; work was to begin in September. He would have more info for next meeting.

Councilman Notaro asked for street paving bids, do we account for curbing and aprons?

Engineer Nassar replied we do, if we were changing the grade of the road. If we change it drastically, we may change the curb and sidewalk. If the contractor damages something, they replace it.

Councilman Notaro added that in his travels he had seen a lot of issues that may need to be addressed in new projects.

Engineer Nassar stated that manholes, etc. get reset. If we break a curb, we replace it. We may have to replace a driveway if we are changing the street grade. If the grade does not change, we do not replace curb or driveways. On Madison Avenue, Engineer Nassar noticed it's in bad shape, so he added it since the contractor will be across the street anyway.

Councilman Notaro asked if there was any update on Wabash?

Engineer Nassar reported it's done.

Councilman Perri asked about the stop bars on Wabash and Northfield?

Engineer Nassar replied it's a punch list item.

### PUBLIC SESSION/FIVE MINUTES PER SPEAKER

Council President Polistina opened the public portion of the meeting for any person to comment on any subject, he asked that they state their name and address for the record and observe the five-minute limit per speaker.

Clerk Canesi stated there was no-one in Zoom.

Seeing no one wishing to make a comment, Council President Polistina closed the public comment portion of this meeting.

At 8:25pm, on motion of Councilman Utts with a second of Councilman Dewees, all members present were in favor of taking a recess.

At 8:38pm Council resumed the regular session.

The Municipal Clerk read the ordinance by title, stated that there would be a public hearing, after which the matter may be considered for final adoption and thereafter published. Since introduction, the full Ordinance has been posted in the lobby of City Hall and on the City website, and copies have been available at no cost by contacting the office of the Municipal Clerk to any member of the public who requested same.

Council President Polistina opened the public hearing.

Jeffrey King, 24 Elizabeth Parkway, Eatontown, speaking on the telephone via Zoom, advocated for cannabis businesses in the community. It was an asset. He appreciated the opportunity to reiterate his support.

Seeing no one wishing to speak he closed the public hearing.

Council President Polistina announced Ordinance 8-2021.

8-2021 An Ordinance by the City of Northfield in the County of Atlantic, New Jersey <u>Prohibiting</u> the Operation of Any Class of Cannabis Businesses within its Geographical Boundaries and Adding Section 215-151b. (16) of the City of Northfield Municipal Code 2<sup>nd</sup> Reading / Public Hearing / Final Consideration Published in the Press of AC 08/14/2021

The Municipal Clerk read the ordinance by title, stated that there would be a public hearing, after which the matter may be considered for final adoption and thereafter published. Since introduction, the full Ordinance has been posted in the lobby of City Hall and on the City website, and copies have been available at no cost by contacting the office of the Municipal Clerk to any member of the public who requested same.

Council President Polistina opened the public hearing.

Jeffrey King, 24 Elizabeth Parkway, Eatontown, via Zoom, urged opposition or tabling. Do not vote in favor of prohibition; it was based on racism, propaganda and misinformation. We have been failing. The drug war was ending and it was time for drug peace. He thanked Council again.

At the request of Council President Polistina, Ordinance 8 was moved first.

Councilman Notaro motioned, second of Councilman Smith, to adopt Ordinance 8-2021.

Clerk Canesi stated the title had already been read, she reiterated the particulars.

Councilman Perri and Councilwoman Madden questioned why we were going out of order.

Discussion ensued between Councilwoman Madden, Council President Polistina, Councilman Perri and Councilman Notaro with regard to why there were two ordinances and the reasons for each.

Council President Polistina read a letter regarding Ordinance 8, from the Planning Board, verbatim, which indicated the Board supported the adoption of Ordinance 8.

Councilman Utts disagreed; he said he was in attendance at the Planning Board meeting, and that was not what was discussed. He reiterated the endorsement to adopt an opt-in ordinance.

Councilman Smith had stated his opinion. A lot could go wrong. Citizens did vote to approve it, and they voted in favor of legalization but not in favor of having it in their town. He read an opinion piece from Dr. Gregory Shengel, President of the Connecticut State Medical Society. He read additional excerpts including the statement that this issue has been cast as a budget matter; it was a health matter, physicians nationwide have seen alarming data from states that have legalized recreational use. This is due to an ever-increasing percentage of THC, which has jumped from 4% in in 1983 to up to 28% in 2018. The study also saw a usage increase of 10% in the 18-25 age group. He felt it was a bad policy and will not support it in any form.

Councilman Utts asked how was banning it in Northfield was going to change anything? If you want to regulate it take it off the street.

Council President Polistina explained that if Ordinance 8 passes, and we still have 7, that has passed at its first reading, and can be passed with one more reading.

Council President Polistina asked a for motion on 8, he wanted to keep 7 available.

Clerk Canesi noted there was already a motion by Councilman Notaro with a second from Councilman Smith for Ordinance 8.

Solicitor Facenda suggested Council President Polistina call for a new motion and a second on whichever Ordinance he wanted to proceed with.

Council President Polistina requested that Council move Ordinance 8-2021.

Councilman Notaro motioned, second of Councilman Smith, to adopt Ordinance 8-2021.

Roll Call: Mr. Dewees - abstain, Mrs. Madden – no, Mr. Notaro – yes, Mr. Perri - no, Mr. Smith – yes, Mr. Utts - no; Mr. Polistina – yes.

Clerk Canesi announced the vote had resulted in a tie, and under our form of government, Mayor Chau would be called upon to break the tie.

Mayor Chau voted yes.

Clerk Canesi read the votes: four in the affirmative, three in the negative and one abstention. The motion carried.

Councilman Smith motioned, second of Councilman Perri, to introduce Ordinance
