#### **COMMITTEE REPORTS**

Councilman Perri said there will be a Senior Committee meeting on Thursday September 26, 2013 in Council Chambers; it is a committee meeting but all are welcome. He also announced there is an upcoming Planning Board meeting on October 3, 2013 which will hear three applications. Regarding the vacant homes, Perri said he did an initial inspection and conferred with the tax collector. 95% of the homes have no outstanding tax or sewer due, the other 5% if they are not habitable, then possibly the city can move forward. Perri will confer with the solicitor and make a recommendation. The list was originally compiled to identify the properties to look at maintenance and code enforcement Perri thanked Cindy Ruffo, Mark Sykes and Kris Facenda for the information on this complicated issue, and said he hopes the City can stay on top of it. The health insurance RFP is out; Perri said he would like to get together with Councilman O'Neill and the Shared Service committee, and reach

out to Linwood on a few issues. He will report back to Council on possible inter locals.

Councilman O'Neill thanked John Capasso from Mainland High School for taking the time to come out and be available for Council's questions regarding the Memorandum of Understanding. Councilman O'Neill thanked the City employees who worked with the students. He reported that the program will be tailored differently this year and anticipates an improved program overall.

Councilman Mahon reported that he met with the County Engineer to discuss the Tilton Road Sewer project as part of an investigation. He also stated he attended the open house at the Museum.

Councilman Polistina reported that there was a special meeting to discuss Capital and any questions should be directed to e him or to CFO Dawn Stollenwerk. He also said the water hook up is underway at Veterans Park and the benches with plaques have been installed. He thanked Engineer Kwapinski and the Public Works Department for their assistance in addressing the drainage issues at the Park. Polistina announced that the Veterans Park Committee will have a table at Funfest this weekend and reminded everyone that bricks and benches are still available.

Councilman Dewees stated that the Household Renovation Debris pick up will be the week of September 23<sup>rd</sup> through the 27<sup>th</sup>.

#### **MAYOR'S REPORT**

Mayor Mazzeo stated that he attended the Museum open house. He reported it was very educational and said there is a section on the school where he saw pictures of himself when he was younger. He appreciates the work done by the Historical Society. He reported that he attended the recent Veterans Park Committee meeting and again thanked M&M Landscaping for their donation and thanked the Committee for their efforts. He reported that there is about \$8,000 remaining from donations. He attended the POW ceremony at the Northfield Community School. He acknowledged that Mr. Webb was also in attendance and he noted that Mrs. Devine did a great job. He said it is a national observation but when one thinks about it the POW's never came home so their families never got closure and this should be remembered every year. He reported that the Northfield Library has hired a new Director, Aubrey Gephart. He noted Aubrey Gephart is good with technology and is expected to be very good in this new position. Mayor Mazzeo reported that the Funfest is taking place this weekend September, 28<sup>th</sup>, from 10am-3pm at Birch Grove Park and shared that the Funfest committee is not planning to serve again next year so we will have to look for a new organizing committee. Mazzeo noted the dedication of Police

Sergeant Eric Dettinger at getting the City hooked up to Comcast internet when the City's T1 line went down. Dettinger is very technologically savvy, and was able to reestablish the City's email and internet service. Mazzeo said Dettinger's efforts are sincerely appreciated. Mazzeo announced that he has sent out a letter to all City employees regarding the appointment of Mary Canesi as the new Personnel Coordinator so everyone would understand what they have to do. Council was also copied on that letter of introduction. Mazzeo concluded by reading the monthly police report.

## **ENGINEER'S REPORT**

The City Engineer's written report was provided to Mayor and Council and is on file in the Municipal Clerk's office. Dan Kwapinski of Schaffer, Nassar, Scheidegg Consulting Engineers, LLC, was in attendance and available for questions. Engineer Kwapinski stated that the football field restroom equipment has come in and construction should start Monday September 30, 2013 and last a couple of weeks. He reported that Tilton Road work is being done and if anyone has questions please contact him, as he has the cell number for the County Inspector. He shared that New Jersey American Water is presently working on replacing water mains and commended the Police Department on the excellent job they are doing with traffic control. The work should be completed on Juniper and Forest shortly and then they will move on to Oakcrest next week. He noted that there have been a few resident questions and they are being addressed by the contractor. Engineer Kwapinski offered to answer questions.

Council President Travagline asked about the drainage issue on Second Street.

Engineer Kwapinski noted he is looking at options. He explained that right now the connection is at Route 9 and the state system. He has asked for documents from the state to see how the connection is made and to see if there are any alternatives to improve the drainage.

Councilman Dewees asked if he had looked at the pipe that runs along Second Street, specifically by the guide rail. Engineered Kwapinski replied that he had not done so yet. Councilman Dewees asked for an update regarding the storm water facilities general maintenance and repair contract bid. Engineer Kwapinski responded that it is in the final stages and he hopes to get it done and ready by the next meeting. Councilman Dewees asked if the current contract has expired. Engineer Kwapinski confirmed that it was, and stated that if work needs to be done they would have to get quotes.

Municipal Clerk Canesi stated that Council can authorize the engineer to go out for bid at the next meeting and that Council should approve the bid specifications..

Mayor Mazzeo asked if the City should adopt the flood maps. Engineer Kwapinski replied that Northfield should adopt the maps so that a Northfield resident would be compliant with the current standards. Mayor Mazzeo asked if Northfield was in any of the flood zones. Engineer Kwapinski responded that Northfield did not have a V-zone area but there were some flood zones in the fringe areas of the City. He stated that during his review of the maps and the corresponding areas there did not appear to be any homes.

Council President Travagline asked about Herbert Drive. Engineer Kwapinski answered that he is looking for information from the old Engineer.

Councilman Perri asked if the New Jersey American Water Company is going curb to curb. Engineer Kwapinski answered that he is looking into this and will discuss it with the contractor to ensure that proper restoration is executed.

Councilman Perri asked if Linwood has awarded the sanitary sewer contract. Engineer Kwapinski answered he did not know. Municipal Clerk Canesi referred to a recently distributed email that indicated Linwood is holding off for now.

Councilman Mahon asked for an update on Tilton Road. Engineer Kwapinski replied that they are working way down the road on curbing and upon completion of that, they will begin reconstruction.

8:00pm Deputy Clerk Marlor left the meeting and did not return.

She provided the hearing and publication dates and noted that the Ordinance is posted on the City website, on the bulletin board at City Hall, and on the City website. Copies are available at no cost in the office of the Municipal Clerk between the hours of 9:00am and 4:00pm, Monday through Friday.

#### PUBLIC SESSION

Council President Travagline opened this meeting to the public and asked if anyone wished to speak on any subject.

Robert Webb, 218 West Revere Avenue, said Mrs. Joyce Pullan sent out a lot of invitations to the Museum open house and it was not very well attended by

representatives from the City. He also stated that Mrs. Devine put on a terrific program at the school and it hit home for him because of his military experience; and we should be proud of her and the school for teaching this to the students. He asked whatever happened to the money from Atlanticare?

Council President Travagline commented that he did not know what Mr. Webb was referring to.

Councilman Perri offered that Mr. Webb is referring to the committee that was formed.

Council President Travagline stated there was a report and he offered to get it for Mr. Webb.

Councilman Perri stated the website still links to Atlanticare. Council President Travagline replied he will get that taken care of.

Craig Tanzola, 10 Magnolia Court, stated that he heard a rumor that Council is looking at the valuation of our town going to the County. Council President Travagline answered that the County did send Northfield a letter and we may look into it. Craig Tanzola stated he was opposed to the idea and he thinks it should be someone who knows our town, like Mark Sykes does. He further stated that he didn't believe County personnel would be familiar with Northfield and that will be to our detriment. He referred to Council members who give up some or all of their salaries and noted that the average salary in Northfield is \$58,000. If Council gave up their salary it might mean the loss of the voice of the people who make \$58,000.

Erland Chau, 1001 Shore Road, stated he agreed with Mr. Webb about the issue of honoring Veterans, and on behalf of the School Board he said that he enjoys honoring the service men and women. He also stated that he spoke with Jerry DelRosso, County Administrator, and they are processing the purchase order to make the necessary repairs to the bus shelter on Shore Road. He commented on the digital billboard on the Margate Causeway and noted that Egg Harbor Township is scheduled this week to introduce a modification to their sign Ordinance. He stated that he was opposed to the proposed changes as he feels any signage on the causeway will affect the Northfield community and urged Council to look at the proposed Egg Harbor Township changes.

Anthony Christopher, 102 Northwood Court, commented that the current hours to Birch Grove Park are 9am to 5pm. He stated that the hours used to be a half hour before sunrise and half hour after sunset. He noted that the campers have full access to the park but he, as a taxpayer, does not.

Council President Travagline noted that he has heard these concerns from Mr. Anthony before and he will address them with Councilman Carew as the Committee chair and Councilman Perri, as  $2^{nd}$ , for discussion at the next meeting.

Mayor Mazzeo suggested that the Birch Grove Park Advisory Board may weigh in and noted that it may be a liability issue since there is no staff on duty. He reminded Council that there used to be a full time resident ranger at the park. He stated he did not know what the answer may be but Council can certainly look into it.

Councilman Mahon commented that there are campers in the park without supervision.

Councilman Perri indicated that he would defer to the recommendation of the Birch Grove Park Advisory Board.

Anthony Christopher requested some sort of permit. Councilman Perri responded that a resident permit may be a good idea.

Council President Travagline asked Councilman Perri to look into the situation. Councilman Perri responded, noting that the Mayor Mazzeo is the chair of the Birch Grove Park Advisory Board.

Mayor Mazzeo suggested to Mr. Christopher that he attend an Advisory Board meeting.

Seeing no one else wishing to speak, Council President Travagline closed the public session.

Councilman O'Neill read the meeting notices.
