Dr. Levitt asked for a motion to approve the minutes from August 4, 2022, September 1, 2022, and October 6, 2022. Mr. Shippen made the motion and Mr. Roegiers seconded the motion. The voice vote was all in favor.

There were four resolutions to memorialize. The first was for NNAC Industry, LLC, Block 41 Lot 10, 1442 New Road, who were approved for a "C" variance and Site plan waiver for minor modifications and a trash dispenser. Abstentions were Mr. Brophy, Mr. Notaro, and Mr. Reardon. The voice vote was all in favor. The second resolution was for Siganos Realty, LLC, Block 41 Lot 22, 1317 Tilton Road and Block 41 Lot 24, 1335 Tilton Road, for a Minor Subdivision to reconfigure the lot lines between the Swift Law Firm and Siganos properties. Abstentions were Mr. Brophy, Mr. Notaro, and Mr. Reardon. Dr. Levitt commented that it would have been useful at the hearing if the Board had known that the City had abandoned and vacated a portion of a public alley as requested by Mr. Siganos. The applicant did not provide this information at the hearing. This occurred in 2015 by Ordinance. Mary Canesi, City Clerk, provided the Ordinance after reading the minutes of the hearing. Mr. Shippen made the motion and Mr. Roegiers seconded the motion. The voice vote was all in favor. The third resolution was for Christine DeRias, Block 95 Lot 16, 1600 New Road, for a "D" use variance to allow a convection oven for baking on premises. Abstentions were Mayor Chau, Councilman Utts, and Mr. Notaro. Mr. Shippen made the motion and Mr. Roegiers seconded the motion. The voice vote was all in favor. The fourth resolution was for Philip Walter Gieseler, Block 120, Lot 11, 116 Roosevelt Avenue, for a "C" variance for a covered porch. Abstentions were Mr. Carney, Mr. Reardon, and Mr. Notaro. Mr. Shippen made the motion and Mr. Roegiers seconded the motion. The voice vote was all in favor.
