

**CITY OF NORTHFIELD, NJ  
ORDINANCE NO. 4-2021**

**AMENDING CHAPTER 111 OF THE CITY OF NORTHFIELD  
MUNICIPAL CODE, ENTITLED VEHICLES AND TRAFFIC**

**BE IT RESOLVED**, that § 111-26.2 of the City of Northfield Municipal code be and is hereby amended as follows (added text underlined, deleted text stricken):

§ 111-26.2 **Speed limit; ~~direction of travel~~; reserved spaces; parking.**

A. No Change

~~B. Traffic within the entire parking lot shall be permitted to flow in a one way direction only, being a counterclockwise direction.~~

~~C.~~ B. Reserved parking spaces designated for police vehicles, for emergency call boxes, and for the Mayor of the City of Northfield shall be designated and identified as such and shall be used by no other person for any other purpose.

~~D.~~ C. All vehicles parking within the parking lot of the Northfield Municipal Building shall park only in properly designated areas and between the lines designating each parking stall.

**BE IT FURTHER RESOLVED**, that § 111-26.4 of the City of Northfield Municipal Code be and is hereby amended as follows (added text underlined, deleted text stricken):

§ 111-26.4 **Entrance and exits.**

Entrance and exit to the City of Northfield Municipal Building parking lot shall be in accordance with the provisions of § ~~111-22~~ and § ~~111-23~~, and as described in Schedule XVIII.

~~§ 111-26.4~~ § 111-26.5 **Violations and penalties.**

Unless another penalty is expressly provided for by applicable New Jersey statutes, every person convicted of a violation of this article or any supplement thereto shall be subject to a fine of not more than \$27, payable through the City of Northfield Violations Bureau.

**BE IT FURTHER RESOLVED**, that § 111-45 of the City of Northfield Municipal Code be and is hereby amended as follows (added text underlined, deleted text stricken):

**§ 111-45 Schedule XVIII: Entrance Only and Exit Only.**

In accordance with the provisions of § **111-22** and § **111-23**, the following described entrances to or exits from the following parking areas are hereby designated as entrance only or exit only. No person shall drive a vehicle through any of the below-described entrances or exits in a direction opposite to the direction indicated:

A. Entrance only.

~~(1) House and Garden Department Store: Both access driveways from Shore Road shall be for entrance only.~~

(1) Northfield Municipal Building; The southerly access driveway along Shore Road shall be for entrance only.

B. Exit only.

(1) Northfield Municipal Building; The northerly access driveway along Shore Road shall be for exit only.

**REPEALER** - All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SEVERABILITY** - If any portion of this ordinance shall be determined to be invalid, such determination shall not affect the validity of the remaining portions of said ordinance.

**EFFECTIVE DATE** - This ordinance shall take effect upon final passage and publication in accordance with law.
