ORDINANCE NO. 4-2022**

**AMENDING CHAPTER 250 OF THE CITY OF NORTHFIELD
MUNICIPAL CODE, PARKS AND RECREATION AREAS**

BE IT RESOLVED, that Chapter 250 of the City of Northfield Municipal Code be and is hereby amended as follows:
