ORDINANCE 5-2012

AN ORDINANCE AMENDING CHAPTER 111-35 OF THE CODE OF THE CITY OF NORTHFIELD TO REMOVE CERTAIN STREETS OR PARTS THEREOF FROM BEING DESIGNATED AS THROUGH STREETS AND AMENDING CHAPTER 111-36 TO ADD STOP INTERSECTIONS

WHEREAS, the City of Northfield has adopted Chapter 111-35 of the City Code, which designates certain streets or parts of streets as through streets;

WHEREAS, the City of Northfield has adopted Chapter 111-36 of the City Code, which designates certain intersections as stop intersections;

WHEREAS, the City of Northfield desires to improve public safety along Davis Avenue with the designation of four way stops; and

WHEREAS, the Police Department of the City of Northfield has recommended that the through street designation be removed from certain streets or parts thereof pursuant to said four way stop project; and

WHEREAS, the Police Department of the City of Northfield has recommended that certain intersections be designated as stop intersections pursuant to said four way stop project; and

WHEREAS, the City of Northfield desires to follow the recommendations of its police department.

NOW, THEREFORE, BE IT HEREBY ORDAINED AND ENACTED by the Mayor and Council of the City of Northfield, County of Atlantic and State of New Jersey as follows:

Section 1. The following streets or parts of streets are removed from the current version of Chapter 111-35 of the Code of the City of Northfield, and the following described streets or parts of streets are no longer designated as through streets:

Name of Street	Limits
Davis Avenue	Between US Route 9 and Fuae Avenue
Section 2. The current version of	Chapter 111-36 of the Code of the Cit

Section 2. The current version of Chapter 111-36 of the Code of the City of Northfield is amended to include the following intersections as stop intersections:

Intersection	Stop Sign On
Davis Avenue at First Street	Davis Avenue
Davis Avenue at Second Street	Davis Avenue

Section 3. This ordinance shall take effect upon final adoption, publication as prescribed by law and final passage and the completion of the installation of the required signs.
